### BUILDING OFFICIAL'S FINAL REPORT

This matter came before the Hearing Officer, Charles M. Thomas, P.E., on June 30, 2009, for a hearing of the complaint filed by David Durkee, P.E., principal engineer for the Clark County Building Division, against Converse Consultants Southwest, Inc. (Converse), and special inspectors Scott T. Edberg, and Joseph G. Laurente. Converse was represented by Greg S. Gilbert, Esq., and Melissa A. Orien, Esq., of the law firm Holland & Hart LLP. Clark County was represented by Clifford M. Jeffers, Deputy District Attorney.

The complaint was filed and the hearing was conducted pursuant to the Clark County Building Administrative Code, Section 22.02.560. The Hearing Officer received evidence from the Building Division and from Converse. After considering the evidence and the arguments of counsel, the Hearing Officer prepared and submitted to the Building Official a report entitled "Findings, Conclusions, and Recommendations of the Hearing Officer."

A copy of the Hearing Officer's report is attached to this Final Report as Exhibit A. The Hearing Officer's report is adopted by reference except as modified below.

### FINDINGS OF FACT

- 1. The evidence is ambiguous concerning Mr. Laurente's ability to read structural plans.
- 2. Many of the non-conformances identified as LBR-NCR-CR-1 through LBR-NCR-CR-276 are already in a condition for resolution.

#### REMEDIES

- 1. The Hearing Officer's recommendation concerning special inspector Scott Edberg is affirmed. His qualification as an approved special inspector is revoked.
- 2. The Hearing Officer's recommendation to suspend the approved status of special inspector Joseph Laurente is affirmed. He may become re-approved upon the following conditions:
  - a. Mr. Laurente must take and successfully pass an accredited structural plans review class approved by the Clark County Development Services Building Division.

- b. Mr. Laurente must retake and successfully pass the International Code Council certification examination for Reinforced Concrete.
- c. Upon completion of these conditions and the appropriate administrative submittals pursuant to the Clark County Building Administrative Code, Mr. Laurente will be reconsidered for listing as an approved concrete special inspector.
- 3. The Hearing Officer's recommendation to suspend Converse as an approved quality assurance agency is modified as follows:
  - a. Converse's qualification as an approved quality assurance agency is suspended for a period not to exceed six months.
  - b. Converse may continue to work projects on which it is already actively engaged to complete its contractual obligations. Converse must notify the Building Official of each of these projects, allowing for increased monitoring by the Building Official.
  - c. Converse's status will be reviewed at the following points:
    - i. Upon the resolution of the non-conformances identified as LBR-NCR-CR-1 through LBR-NCR-CR-276;
    - ii. The satisfactory review by the Building Official of the relevant portions of the City Center verification report;
    - iii. The satisfactory review by the Building Official of Converse's operational and managerial functions for its special inspection program.
