The Defendant above named having committed the crimes of CONSPIRACY TO COMMIT BURGLARY (Gross Misdemeanor - NRS 199.480, 205.060); BURGLARY (Category B Felony - NRS 205.060) and GRAND LARCENY (Category C Felony - NRS 205.220.1, 205.222.2), in the manner following, to-wit: That the said Defendant, on or about the 18th day of May, 2013, at and within the County of Clark, State of Nevada,

# COUNT 1 - CONSPIRACY TO COMMIT BURGLARY

did then and there meet with an unidentified co-conspirator and with each other and between themselves, and each of them with the other, wilfully and unlawfully conspire and agree to commit a crime, to-wit: burglary, and in furtherance of said conspiracy, Defendant did commit the acts as set forth in Count 2, said acts being incorporated by this reference as though fully set forth herein.

### **COUNT 2 - BURGLARY**

did then and there wilfully, unlawfully, and feloniously enter, with intent to commit larceny, that certain building occupied by DONALD MORGAN and/or ERIC PENNEBAKER, located at 3896 South Swenson Street, Apartment No. 316, Las Vegas, Clark County, Nevada.

## **COUNT 3 - GRAND LARCENY**

did then and there wilfully, unlawfully, and feloniously with intent to deprive the owner permanently thereof, steal, take and carry away, lead away or drive away property owned by DONALD MORGAN and/or ERIC PENNEBAKER, having a value of \$650.00 or

more, to-wit: twenty-six (26) video games, shoes and lawful money of the United States; the Defendant being criminally liable under one or more of the following principles of criminal liability, to-wit: (1) by directly committing this crime and/or (2) by aiding or abetting in the commission of this crime, with the intent that this crime be committed, by providing counsel and/or encouragement and by entering into a course of conduct whereby Defendant either took or assisted his co-conspirator in taking said property and/or (3) pursuant to a conspiracy to commit this crime.

C. Garcia, being first duly sworn, deposes and says:

That he is a Detective with the Las Vegas Metropolitan Police Department, being so employed for a period of 7 years, assigned to investigate the crime(s) of Burglary, Grand Larceny and Conspiracy to Commit Burglary committed on or about 05/18/2013, which investigation has developed Savon Goodman as the perpetrator thereof.

THAT DECLARANT DEVELOPED THE FOLLOWING FACTS IN THE COURSE OF THE INVESTIGATION OF SAID CRIME, TO WIT:

### Synopsis

David Morgan was awoken to loud noises coming from inside of his apartment. While investigating the noises Morgan discovered Savon Goodman Inside his apartment. After making eye contact with Goodman, Morgan observed him run out of the aliding patio door. Morgan then checked the apartment and heard footsteps before the front door opened and quickly slammed shut. Warrant of arrest requested on Savon Goodman for the charges of Burglary and Conspiracy to Commit Burglary.

#### Initial Call

On 05/18/2013 at 0050 hours, Roanne Tiongson phoned police to report a suspected prowler in the area of 3896 S. Swenson St. Bldg. #3, Las Vegas, Nevada 89119. Tiongson reported that while returning to her apartment, #315 she observed a black male standing near building #3. As she walked past him she overheard the male making bird noises, "Caw! Caw!" As she continued towards her apartment she observed two black males slowly walking away from the open sliding patio door of apartment # 316. Knowing that the two males were not residents of apartment #316, along with the bird noises being made by the first male she encountered, Tiongson felt something was occurring and contacted police.

### Officers Response

Officers then responded to the scene and obtained a description of the males from Tiongson. While searching for the suspects Officers were contacted by David Morgan, resident of apartment # 316, who advised that his apartment had just been burglarized. Morgan then advised Officers the following. While asleep in his apartment. he was awoken by loud noises coming from inside his apartment. Knowing his roommates had left for the night,

Morgan went to investigate. While in the hallway of his apartment he observed a black male who he immediately recognized as Savon Goodman. After making eye contact with Goodman, Morgan witnessed him running towards the sliding patio door before exiting the apartment. Morgan reported that he then checked the rest of the apartment when he heard additional footsteps moving through apartment before hearing the front door unlock, open and quickly slam shut. Morgan went on to report that Goodman was a friend of his and had previously been inside his residence on multiple occasions.

Officer B. Navarro P# 12616, then completed an Incident Crime Report under LMVPD event # 130518-0140. Morgan later contacted his roommate, Eric Pennebaker who had returned to the apartment and reported that his size 13, Nike, Labron X, "Cutting Jade" basketball shoes had been taken along with \$500.00 cash which was kept inside the shoes. Pennebaker went on to report that the shoes alone were valued at \$800.00.

#### investigation Phase

Detective M. Dardanis P# 9695, while assigned to the Property Crime Detail was assigned to investigate this case. I learned that during the course of the investigation, Det. Dardanis made contact with Morgan who reported that after the initial report he had discovered a total of 26 video games were missing from the residence which he valued at \$885.00. Morgan further advised that when he witnessed Goodman in his apartment, he was standing approximately 10 feet from him and described Goodman as wearing a gray hooded sweatshirt with the hood over his head. However, Morgan advised that while his head was covered, Goodman's face and eyes were clearly visible. Morgan and Pennebaker went on to advise Det. Dardanis that at no time did Morgan or Pennebaker give Goodman or anyone else permission to enter their apartment much less take any of their personal property.

#### Conclusion

Based on the fact that there is evidence to believe that on 05/18/2013 Savon Goodman did enter the residence of Donald Morgan and Eric Pennebaker, 3896 S. Swenson St. #316, Las Vegas, Nevada 89119. That he did so with the intent to permanently deprive Morgan and Pennebaker of personal property valued at over \$650.00. That Morgan did witness Goodman inside the residence during the incident and upon making eye contact with him fled out of the sliding patio door. That while checking the apartment Morgan overheard another suspect unlocking, opening and slamming the front door shut indicating that Goodman had conspired with another person to commit the Burglary. Therefore, I have reason to believe that the crimes of Burglary, Grand Larceny and Conspiracy to Commit Burglary have occurred and that Savon Goodman is the perpetrator thereof.

Wherefore, Declarant prays that a Warrant of Arrest be issued for suspect Savon Goodman on the charge(s) of Burglary, Grand Larceny and Conspiracy to Commit Burglary.
