Det. Raye then asked her how Mainer got injured since he was at the hospital with a stab wound and she repilled that they had gotten into an argument and ne had done it himself. She said he was in the kitchen and ahe was somewhere else in the house, unknown exactly where, and he cut himself. Det. Raya Baked her about the red stains on floor of the kitchans and she sold it was blood and that she had clashed up the broken glass which had cocurred a couple of hours before the "Incident", Rays suked if it was his blood or her blood and she said it was his blood. Rays saked if she had cut herself in any way with the glass or otherwise and she said no, it was Maineri's blood, Allen refused to give a written or taped statement, but gave varied and written consent for criminalistics to process the scene. The consent care was leter

Det. Raye did not observe any injuries on Alien at all and asked her if she had any and she said no. Alien also did not

Det. Schmidt and Sergeent Miller contacted Malneri at Summerlin. Hospital who told us that he and Allen had argued and at one point Mainer "got too close" to Allen and she "was just trying to make a point" and she "accidentally" stabbed him. Mainori was adament the he did not want to get her in trouble and that he had been to jall and jail is a very bad place. When asked why he brought the knike used in the slabbling to the hospital with him he said, "It seemed like a good idea at the time" and maybe the doctor would want to see it. Mainer also told us that after the incident Alien left their residence and he drove himself to the hospital. Malneri refused to give a written or taped statement to Det. Schmidt and Miller, but later, after finding out that Allen was going to be emeated, said that he wanted to recent his story and give a toped statement now in which he would say that he stabbed himself if it would keep her from getting arrested.

Due to the above details Allen was placed under arrest by Det. Rays and transported to C.C.D.C. by Officer M. Casper, p#8549, and booked for Battery With a Deadly Weapon - Domestic Violence for stabbling Maineri and Battery -DV for
