## MEMORANDUM

**DATE:** August 26, 2008

**TO:** NSHE Board of Regents

FROM: James E. Rogers Chancellor

**RE:** HOPE, HOPE THERE IS HOPE

In trying to keep you informed about the devastating effects the Governor's required budget cuts would have, our office has been somewhat between the proverbial rock and a hard place. On the one hand, we felt it essential to give you the facts as they really are: that is, if the Governor's proposed budget cuts really ever became a reality, the System would suffer permanent and irreparable damage. We knew that information would by itself cause great heartburn, not only for all the employees of the System, but even more importantly for all the students present, past and future. Knowing the extent of that heartburn, we still felt it our obligation to give you the bad news.

At the same time, in spite of the Governor's absolutely inflexible position on requiring the System to cut its budget by 14 or 16 percent, regardless of palatable financial solutions that might exist, the Chancellor's office believed there were financial solutions that could accommodate both the fiscal conservatives and liberals of the state of Nevada.

From the enclosed letters the Chancellor's office has received from Senator Raggio, Speaker Buckley, Assemblyman Arberry, and discussions that the Chancellor's office has had with numerous other legislators, the Chancellor's office believes that although the only number yet given the System as a required budget cut is 16 percent, that with perseverance and a team effort between the System and the Legislature a financial resolution can be reached. This resolution may not make any of us completely happy, but such a solution at least will prevent the dismantling of the Nevada System of Higher Education.

The System, certainly all the Regents, the System presidents and all of the employees of the System, in addition to the student bodies of each of the institutions, must continue to give the Chancellor's office ideas for creating financial resources to ensure the future of the System.

Chancellor Rogers:

Since 1985, I have had the privilege to serve in the Nevada State Legislature. I have seen the wild swings of our economy create generous surpluses and cause painful deficits. Through it all, we have been diligent with the taxpayers' money and been thoughtful with the programs the state has supported.

Regardless of partisan opinions, Nevada's legislative leaders and past governors have always worked through these problems together. Last week, Nevada lost one of its classiest and hardest working veterans. While John Marvel and I have vastly different political philosophies, we always found a way to work together to solve the state's problems. This type of cooperation has been both a constant trait and paramount to the success of our state.

The revenue problem we now face, while severe, is not new. However, I am gravely concerned by the current approach being taken to make across the board cuts without review of a particular program's merits.

Further, we risk our economic future by not considering the financial benefits of the very programs we have chosen to fund by blindly cutting them now. Higher education is one area where there is a tangible gain to our economy by offering students access to training, technology and ultimately, degrees. The financial earning capability of an individual with a college education grows dramatically when compared with those who don't.

For over 20 years, I have served on the Ways and Means Committee and have been the Chairman since 1993. During my tenure, I have asked very tough questions of the Nevada System of Higher Education. As you and your staff well know, I am not characterized by rubber stamping budget requests. We demand efficiency and accountability. We spend the entire legislative session reviewing requests for taxpayer money line by line. It is through this rigorous scrutiny that we have gained bipartisan and virtually unanimous support for the expenditures made in higher education. Through this process we have created some outstanding programs that provide benefit to all of Nevada's citizens.

At last week's IFC meeting, I lamented the decisions that were made regarding budget cuts. These cuts were made with too little deliberation. To assign an "average" number in where we cut budgets not only disregards the bipartisan efforts that were put into a particular program, but it flies in the very face of "fiscal conservatism". Just at NSHE alone, how many programs have we created where return on investment, human need and consistent review to ensure the objectives are being met were the standards of determining what we do and don't fund? How do we pick a number out of the air to cut these types of services?

Jim, for the last several months, you have provided great detail and insight as to the impacts these cuts will have on higher education with your weekly memos. By joining forces with the superintendants of the two largest school districts, you have shown that education is a broad state responsibility, not higher education vs. K-12. Not only should these memos be part of the discussion about our budget future, but we should ask for more from you and other state agencies who provide services and value to Nevadans all across the state. Mindless and random percentages as a basis for cuts should not dictate this discussion.

In what will be my final legislative session, I do not intend to stand idly by and decimate decades of bipartisan work. We must be honest with the citizens of Nevada in showing the value that has been created, and the value that will be lost with these cuts. I ask that you continue to provide the information you have been. I also ask that you continue to respond to our questions openly, honestly and expeditiously.
