17 feloniously attempt to kill ELIZABETH HALVERSON, a human being, by the Defendant
18 striking the said ELIZABETH HALVERSON about the head and body, with a deadly
19 weapon, to-wit: a frying pan.

20 COUNT 2 - BATTERY WITH USE OF A DEADLY WEAPON RESULTING IN
21 SUBSTANTIAL BODILY HARM

22 did then and there wilfully, unlawfully and feloniously use force or violence upon the
23 person of another, to-wit: ELIZABETH HALVERSON, with use of a deadly weapon, to-
24 wit: a frying pan, by the Defendant striking the said ELIZABETH HALVERSON about the
25 head and body with said frying pan, resulting in substantial bodily harm to the said
26 ELIZABETH HALVERSON.
