NOTES & HIGHLIGHTS:

Las Vegas hosted more than 3.1 million visitors in April. While down -2.9% compared to last April, it is the smallest year-over-year decline in 11 months (May 2008).

At 88.0%, citywide occupancy for Las Vegas was down 2.0 percentage points vs. last April, which represented the smallest year-over-year decline since March 2008 (13 months). April also saw positive year-over-year increases for weekend occupancy for the first time since December 2007.

The effects of the slowed economy continue to be reflected in lower visitor spending as April showed declines in ADR (-30.7%) and Clark County gaming revenue (-13.6%).
