1 COUNT 1 - DRAWING AND PASSING A CHECK WITHOUT SUFFICIENT FUNDS IN  
2 DRAWEE BANK WITH INTENT TO DEFRAUD, PRESUMPTIONS OF INTENT TO  
3 DEFRAUD

4 did willfully, unlawfully, and with intent to defraud, draw and pass three (3) checks to  
5 obtain cash and/or gaming chips, drawn upon Park Bank, Account No. 5442246, made  
6 payable to HARD ROCK HOTEL AND CASINO, at 4455 Paradise Road, Las Vegas, Clark  
7 County, Nevada, when the said Defendant had insufficient money, property, or credit with  
8 the drawee of the instrument to pay it in full upon its presentation.

11 COUNT 2 - DRAWING AND PASSING A CHECK WITHOUT SUFFICIENT FUNDS IN

14 did willfully, unlawfully, and with intent to defraud, draw and pass a check to obtain  
15 cash and/or gaming chips, drawn upon Park Bank, Account No. 5442246, made payable to  
16 CAESARS PALACE HOTEL AND CASINO, at 3570 South Las Vegas Boulevard, Las  
17 Vegas, Clark County, Nevada, in the amount of \$3,450,000.00, check no. C1122518, when  
18 the said Defendant had insufficient money, property, or credit with the drawee of the  
19 instrument to pay it in full upon its presentation.

20 COUNT 3 - THEFT

21 did then and there knowingly, feloniously, and without lawful authority, commit theft  
22 by obtaining personal property in the amount of \$250.00, or more, lawful money of the  
23 United States of CAESARS PALACE HOTEL AND CASINO, 3570 South Las Vegas  
24 Boulevard, Las Vegas, Clark County, Nevada, by a material misrepresentation with intent to  
25 deprive that person of the property, in the following manner, to-wit: by the Defendant, a  
26 patron of CAESARS PALACE HOTEL AND CASINO, receiving the sum of \$3,450,000.00  
27 cash and/or gaming chips in exchange for check no. C1122518, drawn upon Park Bank,  
28 Account No. 5442246, while falsely representing said check would clear his bank account,  
thereby obtaining the personal property of CAESARS PALACE HOTEL AND CASINO by

1 a material misrepresentation with intent to deprive them of the lawful money of the United  
2 States and/or gaming chips.
