NOTES & HIGHLIGHTS:

Las Vegas welcomed nearly 3.2 million visitors in April, an increase of 0.9% compared to last year. Monthly visitor volumes have matched or surpassed prior year levels for 8 consecutive months.

The 6.1% decline in overall gaming revenue for Clark County reflects lower visitor spending levels. However, please also note that when months end on a weekend, the slot win generated over the last weekend of the month is reported by some properties in the following month.

Although down significantly from peaks of 2007 and 2008, ADR stabilized at approximately \$97, up 3% from April of 2009.
