ON 7-5-10 I OFFICER HULLETT P# 13662 AND OFFICER STAFFORD WERE DISPATCHED TO THE SAHARA HOTEL IN RESPONSE TO A DOMESTIC BATTERY. UPON OFFICER'S ARRIVAL WE MADE CONTACT WITH A FEMALE IDENTIFIED AS ROBLEDU, VANESSA ROBLEDU STATED TO OFFICER STAFFORD THAT SHE WAS IN A FRIENDS VEHICLE WHEN HEN AND HEN BOYFRIEND STARTED TO ARGUE OVER HIS EX-WIFE. ROBLEDU TOLD THE DRIVER OF THE VEHICLE TO STOP SO SHE COULD GET OUT. ROBLEDU TRIED TO EXIT THE VEHICLE WHEN HEN BOYFRIEND GRABBED HER WITH HIS HANDS ON HER UPPER ARMS SHAKING HER THEN PUSHING HER TO THE GROUND. ROBLEDU SAID THEY HAVE BEEN A COUPLE FOR 4 MONTHS AND WOULD NOT GIVE US HIS NAME DUE TO THE FACT THAT HE WAS A POLICE OFFICER. AFTER OFFICER'S INVESTIGATION'S THE BOYFRIEND WAS IDENTIFIED AS WIENN, TOBY. WHEN OFFICER'S ASKED ROBLEDU ABOUT WIENN, SHE BECAME VERY UPSET AT THE FACT THAT OFFICER'S KNEW WHO HE WAS. WIENN AND LT. FLYNN P# 3028 SPOKE VIA ROBLEDU CELL PHONE. WIENN TOLD LT. FLYNN THAT THIS IS ALL JUST A MISUNDERSTANDING AND THAT HE COULD NOT DRIVE TO OUR LOCATION BECAUSE HE HAS HAD TOO MUCH TO DRINK.

ROBLEDU AGREED TO FILE OUT A VOLUNTARY STATEMENT AT WHICH TIME SHE CHANGED HER STORY ABOUT THE ACTIONS THAT HAD TAKEN PLACE. ROBLEDU LATER FILED OUT A CONTINUATION TO HER VOLUNTARY AT WHICH TIME SHE RECOUNTED THE ORIGINAL OFFICER'S SITE WHO ROLO OFFICER'S.
