CRIMINAL COMPLAINT

9 The Defendant above named having committed the crimes of COERCION (Felony -
10 NRS 207.190); ROBBERY (Felony - NRS 200.380); GRAND LARCENY (Felony - NRS
11 205.220, 205.222); BATTERY CONSTITUTING DOMESTIC VIOLENCE (Misdemeanor -
12 NRS 200.481; 200.485; 33.018) and HARASSMENT (Misdemeanor - NRS 200.571), in the
13 manner following, to-wit: That the said Defendant, on or about the 9th day of September,
14 2010, at and within the County of Clark, State of Nevada,

15 COUNT 1 - COERCION

16 did then and there wilfully, unlawfully, and feloniously use physical force, or the
17 immediate threat of such force, against KORAUN MAYWEATHER, with intent to compel
18 him to do, or abstain from doing, an act which he had a right to do, or abstain from doing, by
19 threatening to "beat" the said KORAUN MAYWEATHER if he called 911 and/or left the
20 residence.

21 COUNT 2 - COERCION

22 did then and there wilfully, unlawfully, and feloniously use physical force, or the
23 immediate threat of such force, against ZION MAYWEATHER, with intent to compel him
24 to do, or abstain from doing, an act which he had a right to do, or abstain from doing, by
25 threatening to "beat" the said ZION MAYWEATHER if he called 911 and/or left the
26 residence.

1 COUNT 3 - ROBBERY

2 did then and there wilfully, unlawfully, and feloniously take personal property, to-
3 wit: a cellular telephone, from the person of JOSIE HARRIS, or in her presence, by means
4 of force or violence, or fear of injury to, and without the consent and against the will of the
5 said JOSIE HARRIS.

6 COUNT 4 - GRAND LARCENY

7 did then and there wilfully, unlawfully, and feloniously with intent to deprive the
8 owner permanently thereof, steal, take, carry, lead or drive away property owned by JOSIE
9 HARRIS, having a value of \$250.00, or more, to-wit: a cellular telephone.

10 COUNT 5 - BATTERY CONSTITUTING DOMESTIC VIOLENCE

11 did then and there wilfully and unlawfully use force or violence against or upon the
12 person of his spouse, former spouse, any other person to whom he is related by blood or
13 marriage, a person with whom he is or was actually residing, a person with whom he has had
14 or is having a dating relationship, a person with whom he has a child in common, the minor
15 child of any of those persons or his minor child, to-wit: JOSIE HARRIS, by grabbing the
16 said JOSE HARRIS by the hair and throwing her to the floor and/or striking her with a fist
17 and/or twisting her arm.

18 COUNT 6 - HARASSMENT

19 did then and there wilfully and unlawfully threaten to cause bodily injury in the future
20 to the person of JOSIE HARRIS and/or her boyfriend, by threatening to kill the said JOSIE
21 HARRIS and/or her boyfriend and/or make her and/or her boyfriend "disappear."

22 COUNT 7 - HARASSMENT

23 did then and there wilfully and unlawfully threaten to cause bodily injury in the future
24 to the person of KORAUN MAYWEATHER, by threatening to "beat" the said KORAUN
25 MAYWEATHER'S "ass."
