Re: **Election Issues in Washoe and Clark Counties**

Dear Matthew,

As you know, based on our numerous conversations with you which began prior to the commencement of early voting, the Nevada Republican Party (NRP) has requested from each County Clerk or Registrar of Voters copies of the daily logs for each of their early voting polling locations. These logs specify, among other things, the opening and closing total ballot counts each day from the voting machines at each location, the number of voters who signed in to vote that day, the number of provisional ballots cast, and other information important to the transparency of the administration of the election. It should be noted that these records do not contain a tabulation of votes cast for any particular candidate. The logs are referred to as "Polling Place Statements" in Clark County and "Early Voting Daily Balance Sheets" in Washoe County.

In conversations with your office, you have advised that it is your belief that these are public documents which the NRP is entitled to receive and review. For the most part, the county clerks and registrars of voters have agreed to provide us these documents on a daily basis¹, with the following exceptions:

- The Clerk of Esmeralda County has declined to disclose these records until after the election.
- In Washoe County, the Registrar of Voters informed one of our attorneys, Cord Byrd, that he would not provide the

records for at least two (2) or three (3) days after receipt in his office, so that he may first "calibrate" and "correct" the data. Presently, we have received documents from Washoe County only for the first four (4) days of early voting - Oct 16 through 19 - although there have now been nine days of early voting.

- In Clark County, the Registrar of Voters has been providing us the records for each day of Early Voting the following morning, although his office has changed the format of the forms themselves since the commencement of early voting (see below).

This letter formally notifies the Secretary of State, as Nevada's chief elections officer, of some of the issues and discrepancies we have identified in the daily Early Voting logs from Clark and Washoe Counties, as well as the responses we have received from the registrars of those counties when we brought these issues to their attention. We are in the process of reviewing the records we have received from several other counties, and will notify your office as well as the registrars or county clerks of any issues or discrepancies in those daily results.

I. CLARK COUNTY ISSUES

A. Change in Polling Place Statement Format

The Clark County Registrar of Voters changed the format of his office's Polling Place Statements in the midst of Early Voting, thereby inadvertently eliminating an important safeguard that allowed the Registrar to confirm the validity of the ballot counts from the county's voting machines. The Polling Place Statement form that Clark County used during the first two days of Early Voting required polling place workers to manually record the Beginning Count from each voting machine when the polling location opened at the beginning of the day. The Registrars' office could then independently compare this figure with that machine's Ending Count from the preceding evening, to ensure that no ballots were erroneously added or subtracted while the polls were closed. An example of the original format is included as Attachment 1.

On the third day of Early Voting, however, for most polling locations, the Registrar began preprinting on the forms what the

Beginning Count for each machine was **supposed** to be, and directed poll workers to check a box to "verify" that these pre-printed figures are accurate. An example of this new format is included as Attachment 2. Pre-printing the "correct" answer on each form obviously is less secure than requiring poll watchers to record data from voting machines without giving them the answers in advance, and effectively precludes the Registrar's office - or the public - from being able to independently verify those figures.

When these issues were raised with the Registrar, he responded that he changed the format of the forms because allowing poll workers simply to check a series of "verify" boxes saved them time. Furthermore, he claimed that it was unnecessary to have additional confirmation that the number of ballots recorded on each machine in the morning is consistent with the figure from the evening before.

Request: We respectfully request that the Polling Place Statement forms be returned to their original format, which required poll workers to manually enter the Beginning Counts from each voting machine, and did not have the "correct" answers preprinted on them.

**B. Failure to "Verify" Voting
Machines' Beginning Ballot Counts**

Needless to say, any mismatch between the number of ballots recorded on a machine when a polling place opens in the morning, and the number of ballots on that machine when the polling place closed the evening before, is deeply concerning. On several of Clark County's Polling Place Statements (using the new format), the "verify" boxes for the Beginning Ballot Counts from certain voting machines were not checked. Specifically:

- Oct. 18, 2010 - Trailer #2 polling location - the "verified" box was not checked for Machine #34222 (see Attachment 3);

- Oct. 19, 2010 - Trailer #2 polling location - the "verified" box was not checked for **any** of the voting machines (see Attachment 4);

- Oct. 19, 2010 - Meadows Mall polling location - the "verified" box was not checked for Machine #34007 (see attachment 5);

- Oct. 20, 2010 - Mobile Team #9 polling location - the "verified" box was not checked for Machine #34437 (see attachment 6); and

- Oct. 21, 2010 - Trailer #2 polling location - the "verified" box was not checked for **any** of the voting machines (see Attachment 7).

When several of these examples were brought to the Clark County Registrar's attention, he responded that, although his office had not investigated any of these incidents, he was confident that these failures to check the "verify" boxes were merely oversights, and did not indicate that any discrepancies may exist. He explained that poll workers are required to call his office if the Beginning Count preprinted on the Polling Place Statement differs from the Beginning Count on the corresponding voting machine. The fact that his office did not receive any such calls confirms that no such discrepancies existed, despite the fact that the "verify" boxes were left unchecked for certain machines.

Request: We respectfully request that your office investigate, or direct an investigation of, any voting machines for which the Polling Place Statements fail to establish that the Beginning Count was verified, and publicly disclose the results of any such investigation.

II. CLARK AND WASHOE COUNTY ISSUES

A. "Extra" Votes Recorded on Voting Machines

On several days, in both Clark and Washoe Counties, the number of ballots cast at certain polling locations exceeded the number of voters who signed the election register to vote at those places. Specifically:

- Oct. 17, 2010 - Clark County, Pearson Community Center polling location - 220 ballots were recorded, but only 219 people signed the voting register (see attachment 8);

- Oct. 18, 2010 - Clark County, Centennial Center polling location - 1,216 ballots were recorded, but only 1,215 people signed the voting register (see attachment 9);

- Oct. 18, 2010 - Clark County, Boulevard Mall polling location - 878 ballots were recorded, but only 877 people signed the voting register (see attachment 10);

- Oct. 19, 2010 - Washoe County, Scolari's Store #20 polling location - 458 ballots were recorded, but only 457 people signed the voting register (see attachment 11);

- Oct. 19, 2010 - Washoe County, South Valleys Library polling location - 567 ballots were recorded, but only 566 people signed the voting register (see attachment 12);

- Oct. 23, 2010 - Clark County, East Las Vegas Community Center polling location - 333 ballots were recorded, but only 331 people signed the voting register (see attachment 13); and

- Oct. 23, 2010 - Clark County, Boulevard Mall polling location - 772 ballots were recorded, but only 771 people signed the voting register (see attachment 14).

These troubling discrepancies suggest that these voting machines may have recorded extra votes erroneously, or that people were allowed to cast votes without signing up (thereby potentially allowing them to cast multiple ballots).

Request: NRP requests that your office review and resolve, in a public and transparent manner, any discrepancies in which the number of ballots recorded at a polling place on a particular day exceeds the number of people who signed in to vote there, so that all parties and candidates, as well as the voting public, can be assured of an error-free election.

B. Audit Board

When some of the discrepancies described above were brought to the attention of the Clark County Registrar of Voters, he declined to disclose whether they had been investigated or resolved, or the steps, if any, that had been taken to ensure that similar problems did not recur. He instead replied that a special Audit Board reviewed and attempted to resolve discrepancies in the data from polling places after the polls closed each evening. This was the first notice we have received of the existence of an 'Audit Board'

that reviewed election or voting discrepancies. The Registrar declined our requests for a copy of the Board's charter, policies, rules, guidelines, or procedures, or any other information regarding its operations. He stated that neither general information about the Board, nor information about any particular matters it has resolved or is investigating, will be available until he testifies before the Clark County Board of Commissioners in connection with the countywide canvass, after the election.

As noted earlier, the Washoe County Registrar of Voters stated that it would take several days for him to disclose his county's Early Voting Daily Balance Sheets, due to the need to "correct" and "calibrate" the data. It is unclear whether he also is relying on an Audit Board to do so, or if he has established some other mechanism or procedure to review and revise this information.

Request: We request that your office direct the immediate public disclosure of information regarding counties' Audit Boards, including their establishment, members, policies, procedures, rules, and the matters they are investigating, or have investigated, in connection with this election (including, but not limited to, the nature of each such problem or discrepancy; the polling location(s) and voting machine(s) where it arose; the number of ballots, signatures, and/or voters potentially affected; and the manner in which it was resolved).

C. Handwritten Changes to Daily Logs

Numerous Polling Place Statements from Clark County and Early Voting Daily Balance Statements from Washoe County contain substantial handwritten changes and revisions. In some cases, ballot count figures have been crossed out and replaced with different numbers (see, e.g., Attachments 14 and 15). In several statements from Washoe County, it appears that white out or tape was placed over certain figures, and then the form was re-copied so that the original figures would be completely obscured (see, e.g., Attachment 16). There do not appear to be any guidelines specifying who has the authority to make such revisions, the circumstances under which they may be made, and what, if anything, is done to confirm their accuracy. The Clark County Registrar of Voters indicated that he does not investigate any such revisions or changes on Polling Place Statements.

Request: We respectfully request that your office investigate, or direct an investigation of, all handwritten changes, edits, or revisions to Polling Place Statements, Early Voting Daily Balance Sheets, and other such documents, and direct the promulgation of guidelines concerning the circumstances under which such revisions may be made, and the safeguards that must be established to prevent erroneous or fraudulent changes.

D. Exceptions and Exception Logs

Several of Clark County's Polling Place Statements indicate that information regarding potential errors and discrepancies may be found in a separate "Exception Log" (see, e.g., Attachment 9). It appears that these Exception Logs document and, in many cases, explain apparent inconsistencies in the data concerning voting machines and polling places. The public disclosure of these logs is essential to bolster public faith in the accuracy of the election process and explain the basis for any apparent discrepancies.

Request: We respectfully request that your office direct the public disclosure of exception logs and other similar documents that reflect any problems, malfunctions, or discrepancies with voting machines or election registers or databases. Documents relating to the actions taken by a county clerk or registrar to resolve any issues noted in an exception log also should be subject to disclosure.

CONCLUSION

These issues and discrepancies are troubling, especially in light of the Registrars' responses. We believe that all Nevadans – especially those, like you, in the Secretary of State's office – want to be assured that every legal voter in this State is allowed to vote, and that their validly cast ballots are not diluted or effectively nullified by erroneously, fraudulently, or otherwise impermissibly recorded votes. Maintaining audit boards with secret procedures, eliminating certain ballot integrity safeguards midway through the election, and declining to investigate or explain obvious discrepancies creates an appearance that the election is not being conducted transparently.

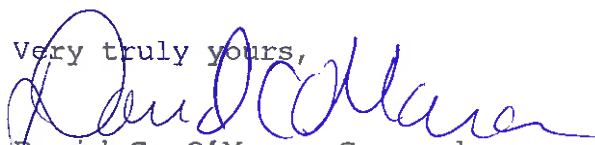

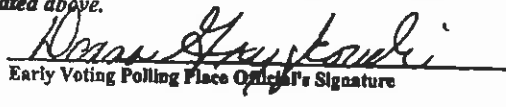
