9 The Defendant above named having committed the crime of DRIVING AND/OR  
10 BEING IN ACTUAL PHYSICAL CONTROL WHILE UNDER THE INFLUENCE OF  
11 INTOXICATING LIQUOR CAUSING DEATH AND/OR SUBSTANTIAL BODILY  
12 HARM (Category B Felony - NRS 484C.310, 484C.430), in the manner following, to-wit:  
13 That the said Defendant, on or about the 5th day of February, 2012, at and within the County  
14 of Clark, State of Nevada, did then and there wilfully, unlawfully, and feloniously drive  
15 and/or be in actual physical control of a motor vehicle, to-wit: a 2005 Acura, bearing  
16 Nevada License No. LVVM22, on or off the highways, to-wit: Spring Mountain Road and El  
17 Camino Road, Las Vegas, Clark County, Nevada, while under the influence of intoxicating  
18 liquor to any degree, however slight, which rendered her incapable of safely driving and/or  
19 exercising actual physical control and/or while she had a concentration of alcohol of .08 or  
20 more in her blood or breath, and/or when the Defendant was found to have a concentration  
21 of alcohol of .08 or more in her blood in a blood sample which was taken within two (2)  
22 hours after driving and/or being in actual physical control of said vehicle, said Defendant  
23 failing to pay full time and attention to her driving and/or by failing to exercise due care  
24 and/or failing to drive in a careful and prudent manner and/or failing to maintain travel lane  
25 and/or driving off the roadway, which acts, or neglect of duties, proximately caused the  
26 vehicle being driven by Defendant to strike and collide with that certain pedestrian, CONAN  
27 OBENCHAIN, said collision proximately causing substantial bodily harm to CONAN  
28 OBENCHAIN.
