

IMPORTANT INFORMATION ABOUT YOUR FIRE ALARM SERVICE

Dear Valued ADT Customer:

The Henderson City Council recently passed an ordinance amending the City of Henderson Fire Code to prohibit alarm companies from directly notifying the Fire Department on fire alarms from residential fire alarm systems without there first being eyewitness verification that a fire actually exists. The prohibition against direct alarm company notification to the Fire Department also applies to fire alarm generated by using the keypad "fire" button and commercial fire alarm systems unless the property is also protected by a water-flow system or the fire event is visually verified by an eyewitness. The ordinance, which became effective October 1, 2007, does not affect Police response to alarm systems. If your fire system includes a sprinkler water flow system, the fire department will respond as usual.

If your alarm system is not in the jurisdiction of the Henderson Fire Department, please disregard this letter.

Please take notice that, as of October 1, 2007, ADT is prohibited from asking the Henderson Fire Department to respond to a fire alarm until there is visual verification of a fire.

While ADT and the alarm industry strongly feel the new ordinance disregards vital life/safety concerns and is not the best method for addressing the issue of false fire alarms, ADT is nevertheless well-positioned to begin adhering to the new fire code requirements. Upon receipt of a fire alarm from a customer's premises ADT's revised alarm notification procedures are

- 1. Attempt to contact the customer's premises by telephone to verify whether an alarm event is real.
- In the event ADT is unable to contact someone at the customer's premises, a verification call attempt is made to the designated people on the customer's emergency call list to verify the alarm event.
- 3. If the customer or someone on the emergency call list verifies that they see evidence of a fire, ADT notifies the fire department.
