20	Q	Is that Tuesday around the 16th?
21	A	Yes.
22	Q	What type of interaction did you have with
23	Raven on that	t day?
24	A	Well, I had come downstairs to put the garbage
25	out and I sav	w her sitting on the couch and I asked her how
	-	

1	she was doing and she didn't respond.
2	Q How did she appear?
3	A She appeared I don't know what the word
4	really is except that she was very quiet, kind of
5	withdrawn.
6	Q So you didn't have any type of extended
7	conversation with her at that moment?
8	A At that moment, no. I put the garbage into, I
9	pulled the garbage bag out of the garbage can and headed
10	for the front door and then she stopped me and asked me
11	what I was doing, wasn't garbage night or, well, garbage
12	day was Tuesday, not Wednesday, but I replied that it was
13	Wednesday and that everyone else's garbage was out already.
14	Q At some point did you have contact with
15	detectives of the Las Vegas Metropolitan Police Department?
16	A Yes.
17	Q And did you eventually sit down and give them
18	a taped interview?
19	A Yes, I did.
20	Q And did you cooperate with them fully?
21	A Yes, I did.
22	Q Did you tell them everything that you knew?
23	A Yes.
24	MR. HENDRICKS: I have no additional questions
25	if anyone else has any.

16 THE FOREPERSON: No. By law these proceedings are secret and you are prohibited from disclosing to anyone anything that 3 has transpired before us, including evidence and statements 4 presented to the Grand Jury, any event occurring or 5 6 statement made in the presence of the Grand Jury, and information obtained by the Grand Jury. 8 Failure to comply with this admonition is a gross misdemeanor punishable by a year in the Clark 9 10 County Detention Center and a \$2,000 fine. 14	having been first duly sworn by the Foreperson of the Grand
15	Jury to tell the truth, the whole truth, and nothing but
16	the truth, testified as follows:

21	Q Good afternoon Detective Popp. How are you?
22	A Fine. How are you?

18	A	I worked with Detective Laura Anderson and
19	Detective Je:	ff Rosgen, R-o-s-g-e-n.
20	Q	Now in regards to this particular
21	investigation	n, when were you first notified that you would
22	be involved	in this investigation?
23	A	At approximately 8:30 in the morning on the
		with missing persons detective Tom Marin.
25	Q	We're talking about January 19th of 2007,

	2	A	Yes.
	3	Q	Did you have an opportunity to speak with
	4	Detective M	larin?
	5	A	Yes.
	6	Q	Did you eventually respond to 3373 Milenko
	7	here in Las	Vegas, Clark County, Nevada?
	8	A	Yes.
	9	Q	What was the purpose of going to that
	10	residence?	
	11	A	Initially to assist Detective Marin in
	12	interviewin	ng a person named Raven Navajo.
	13	Q	Who was with you when you arrived there?
	14	A	Myself, Detective Anderson, our sergeant Will
	15	Scott, and	then the other members of the missing persons
	16	squad.	
	17	Q	Did you make contact with Raven Navajo at that
	18	residence?	
	19	A	No, I did not.
	20	Q	Did you make contact with anyone at that
	21	residence i	f you recall?
	22	A	Yes, I did.
	23	Q	Who was that?
	24	A	Barbara Casey and Mari Rosenberger.
	25	Q	Did you have an opportunity to speak with them
		1	

1	on that day?	
2	A	Yes, we did.
3		Did you actually tape conversations with both
4	those indivi	duals?
5	A	Yes.
6	Q	And were you able to determine whether or not
7	those indivi	duals resided at that location?
8	A	Yes, we did.
9	Q	Now did you at any point go into that
10	residence?	
11	A	Yes, I did.
12	Q	Was that with the consent of one of those
13	individuals?	
14	A	Yes.
15	Q	Who was that?
16	A	Barbara Casey.
17	Q	And once you went inside the residence what
18	did you obse	rve if anything?
19	A	Just the basic interior of the residence. It
20	wasn't until	after we concluded the interview with Barbara
21	that with he	r permission I looked into the garage area.
22	Q	What did you observe once you went inside the
23	garage area?	
24		I noticed what I believed to be a necklace
25	lying on the	floor just inside the garage on the concrete

1	and then var:	ious stains that appeared to be apparent blood
2	to me.	
3	Q	What did you do after you saw those things?
4	A	I asked Barbara and Mari to exit the
5	residence, we	e secured it, and then Sergeant Scott applied
6	for a search	warrant.
7	Q	Why did you do that?
8	A	Based on my experience I believed that it
9	might possib	ly be a crime scene and to investigate further
10	we wanted to	make sure that we did it properly.
11	Q	Do you know if there was a search warrant that
12	was eventual	ly obtained?
13	A	Yes.
14	Q	Were you part of the searching process in
15	regards to the	nat residence?
16	A	No. I had already left after the warrant was
17	obtained.	
18	Q	Now you said that you left that residence that
19	you had thoug	ght was a crime scene, correct?
20	A	Yes.
21	Q	Do you recall where you went, Detective?
22	A	To 953 East Sahara, an office of an attorney
23	named Christ:	ina DiEdoardo I believe is how you pronounce
24	it.	
25	Q	What was the purpose of going to that office?

17	1	A	To meet with Raven Navajo and her attorney
	2	Christina Di	Edoardo.
	3	Q	Did you arrive there?
	4	A	Yes.
	5	Q	Who were you with?
	6	A	I was with Detective Anderson.
	7	Q	Did you get the opportunity to speak with
	8	Raven Navajo	in regards to that individual?
	9	A	Yes, we did.
	10		MR. HENDRICKS: Yes, please, Mr. Stanton.
	11		MR. STANTON: Showing you 4A, Detective.
	12	BY MR. HEND	RICKS:
	13	Q	Do you recognize the individual depicted in
	14	that photo?	
	15	A	Yes, I do.
	16	Q	Who is that?
	17	A	That's Raven Navajo.
	18	Q	Is that the same individual you met with on
	19	January 13th	at that East Sahara office?
	20	A	Yes.
	21	Q	You said that Raven was with another
	22	individual,	correct?
	23	A	Yes.
	24	Q	And that person indicated to you that she was
	25	Raven's atto	rney, correct?

17	1	A That's correct.
	2	Q Now did you have any conversations with Raven
	3	prior to meeting with the attorney?
	4	A No, I did not.
	5	Q Now the conversations that you had with Raven,
	6	was the attorney present?
18	7	A Yes.
10	8	Q How did that take place?
	9	A Initially once we arrived at the residence and
	10	learned that Raven wasn't there, I asked that the missing
	11	persons detectives go to this attorney's office to see if
	12	they could locate Raven. One of the missing persons
	13	detectives had received a phone call from this attorney
	14	stating that if we spoke to Raven she would like to be
	15	present and gave an indication that Raven may either be on
	16	her way or be at that office, so once they arrived there

13	Q	Now did you stop the tape at that point?
14	A	Yes, I did.
15	Q	Did you provide Miss Navajo the opportunity to
16	speak with h	er attorney again?
17	A	Yes.
18	Q	And at some point did you turn the recording
19	back on?	
20	A	Yes.
21	Q	About how long of a break was there if you
22	recall?	
23	A	I would say less than ten minutes.
24	Q	Was there just one break or was there more
25	than one brea	ak?

Α There was just one break. Q Now once you went back on recording were you 3 able to speak with Miss Navajo? 4 Α Yes. 5 And was Miss Navajo's attorney still present during that entire time? 6 Α Yes. 8 All the way until the end of the interview was 9 the attorney present? 10 Yes. 11 Q Did you take any other breaks if you recall? 12 Α No. And if you could go ahead and describe for 13 Q these folks what the content of that conversation was 14 between yourself, the other detective and Miss Navajo. 15 16 The conversation was directed at Raven Α regarding her association with a female that was missing by 17 the name of Brenda, and I'll botch her last name if I try 18 to pronounce it. Raven acknowledged that she knew Brenda 19 and proceeded to explain what happened to Brenda and how 20 she turned up missing. She stated that she was very drunk, 21 was at a bar called Zodie's which is located on East 22 Flamingo. 23 Detective, let me stop you there for a minute. 24 Q 25 Α Okay.

point during the interview? 2 3 I would call it non-emotional, very almost stoic, and at some point during the interview agitated. 4 5 Now when you say that Raven was communicating to you that she was drunk, you're talking about the day in 6 question and not during the interview, correct? 8 Α Correct, yes. Sorry. Yes. Q Okay. Just wanted to clairfy that. 10 Now during this interview she Raven had 11 indicated to you that she was drunk? 12 Α Correct. 25	Q	Did Raven say how she had come into having \$80

	2	A Yeah. She said that she had won a jackpot in
	3	the bar a couple days prior for approximately \$1700.
	4	Q Did Raven indicate to you whether or not
	5	Brenda had requested that or she just gave it to her?
	6	A She said that she just gave it to her. In
	7	fact I believe she indicated that Brenda refused to take it
	8	at first, she sort of forced it on her by leaving it on the
	9	bar.
	10	Q Now at some point did Raven and Brenda leave
		Zodie's?
	12	A Yes.
	13	Q And did Raven indicate approximately what time
		that was?
	15	A No, I don't believe she recalled.
	16	Q But you think it was during that January 13th
	17	date based upon what Raven had previously told you?
	18	A Yes.
	19	Q Did she indicate where they went?
	20	A Yes.
	21	Q Where was that?
	22	A To her residence, 3373 Milenko.
	23	Q Approximately how far away is Zodie's from
	24	that location you just stated?
	25	A It's relatively close. I would say within a

mile or two. What did Raven tell you happened once she and Brenda arrived at Raven's home? 3 They went upstairs to Brenda's, I'm sorry, to 4 5 Raven's room, Brenda laid on Raven's bed while Raven went into the bathroom. Raven said that when she finished in 6 the bathroom she came out and retrieved her purse, meaning Raven's, from the floor to retrieve the rest of the cash 8 that she had been keeping in there from this jackpot that 9 she won. When she picked up the purse and looked inside 10 she realized it was empty and assumed at that point that 11 Brenda had taken the rest of her money. 12 Q Let me stop you there, Detective. In regards 13 to Brenda, did Raven ever give a physical description of 14 15 Brenda to you? 16 Α Yes. 17 Q What was that if you recall? 18 Α I believe she described her as being about five foot seven, a hundred twenty pounds or so. 19 Any other decriptors; white, black, Hispanic? 20 Q 21 White female with blonde hair. Q Yes, in the garage. 4 Α 5 Did she give you any other details in regards 6 to how many times she struck the victim? She said she couldn't recall how many times she struck the victim, only that it was multiple. 8 Did Raven ever indicate to you whether or not she had checked to see if the victim was still alive? 10 11 Α Yes. 12 What did she tell you? Q After she finished hitting Brenda she went 13 Α inside, changed her clothes, put those clothes into her 14 closet, put on a nighty and went downstairs and laid on the 15 couch for approximately four hours. After that four hour 16 period she got up and went into the garage and determined 17 18 that Brenda was deceased. 25	Q	Now once you she arrived there, did you guys

1	take photos, you being the Metropolitan Police Department
2	members, crime scene analysts or whoever, did they take
3	photos?
4	A Crime scene analysts were called to our office
5	and took photos, yes.
6	MR. STANTON: 4B through 4J.
7	BY MR. HENDRICKS:
8	Q If you could, Detective, look through those
9	Grand Jury exhibits briefly and then we'll go through them
10	one by one and if you could describe what is depicted in
11	each one of those as Mr. Stanton places them on the screen.

2	Q Now Detective, let me ask you this: This
3	event that Raven had described to you took place on January
4	13th, correct?
5	A Yes.
6	Q And is this now January 19th, six days
7	later
8	A Yes.
9	Q when you were photographing those injuries?
10	A That's correct.
11	MR. STANTON: 4D and E. 4D.
12	THE WITNESS: 4D would be a photo of Raven's
13	upper right shoulder and there is an apparent injury to the
14	arm just above, or just below the shoulder there.
15	MR. STANTON: 4E.
16	THE WITNESS: That would be another photo
17	of that's just a closeup of that particular injury.
18	MR. STANTON: 4F.
19	THE WITNESS: That would be the left forearm
20	of Raven and another injury in the center of the screen or
21	towards the top of the screen.
22	MR. STANTON: 4G.
23	THE WITNESS: Again the left forearm with a
24	apparent injury right above the elbow.
25	MR. STANTON: 4H and 4I.
