

The following is the transcription of the recorded Application for Search Warrant between affiant, Detective C. Bunting (CB), P#6484 and Judge James Bixler (JB).

CB. Okay, Judge Bixler, for the record this line is being recorded.

JB. That's fine.

CB. Do I have your permission to continue?

JB. Yes, you do.

CB. This is Detective Bunting, P#6484, of the Las Vegas Metropolitan Police Department Violent Crimes Section and I am making an application for a Telephonic Search Warrant pursuant to NRS 179.045. I am talking to Judge Bixler and the date is 08-24-09 and the time is 0521 hours. Judge Bixler, could please swear me in?

JB. Sure, raise your right hand please.

CB. It is.

JB. Do you swear the testimony you're about to give in this oral affidavit is true and correct to the best of your knowledge so help you God?

CB. Yes sir, I do.

JB. Alright, go ahead and proceed.

CB. Judge Bixler, my application is as follows: I, Detective C. Bunting, P#6484, am currently employed by the Las Vegas Metropolitan Police Department and have been so employed for a period of nine years. I am currently assigned to the Violent

Crimes Section and have been assigned to this detail for the past four years. I am presently investigating the crime of Assault With a Deadly Weapon two counts, which occurred at 4680 Boulder Highway, Las Vegas, Nevada, Clark County, 89122 on or about 2206 hours on the 23rd day of August 2009.

That there is probable cause to believe that certain property hereinafter described will be found at the following described premises to wit:

1. Number 2 Woodcreek Court, Las Vegas, Nevada 89141. It is a two story single family residence. The entryway is composed of multi-colored stone. Entry in the home is through a double glass framed doors. The front doors face south and the number 2 is painted in gold on a blue green plate that is attached to a pole underneath the mailbox.
2. A 2008 Rolls Royce bearing Nevada license plate 463VKE. The vehicle is a two tone gray over blue, four door vehicle and the R/O is Mayweather Promotions LLC Floyd Joy Mayweather and the vehicle is parked in the driveway of the residence. The persons of adults or minors located at the premises at the time of the execution of this Warrant.

The property referred to and sought to be seized consists of the following:

Firearms, ammunition, gun magazines, spent shell casings to a firearm, limited items of personal property which would tend to establish a

possessory interest in the items seized pursuant to this Search Warrant to include, but not limited to personal identification, photographs, utility receipts, addressed envelopes showing the names of the persons residing at the premises, written correspondence, diaries, financial records, wills, like items which may provide information as to the motive or identity of the perpetrator. Telephonic information to include called I.D. history, answering machine messages, phone directories, and call history stored electronically in residential or cellular phone. Photographs, videos, or audio tapes which may disclose the identity of the persons associated with the victim or suspect. A thorough microscopic examination and documentation of the crime scene to discover trace evidence to include, but not limited to fingerprints, blood, hair, fibers and other bodily fluid samples.

The items sought to be seized constitute evidence which would tend to show the identity of the persons responsible for the crimes of Assault With a Deadly Weapon as set forth in this affidavit in support of the assertion to constitute the existence of probable cause the following facts are offered:

On 08-23-09 at approximately 2206 hours LVMPD Dispatch received a call from Beatrice Turner under Event #090823-3515. Turner stated she was informed by Security Officer Eli he heard multiple gunshots coming from the area of the Crystal

Palace at 4680 Boulder Highway, Las Vegas, Nevada 89122. Las Vegas Metropolitan Police Department patrol officers arrived at the scene and located four witnesses and seven cartridge casings. Violent Crimes Detective Harding, P#6080, made contact with the witnesses and learned an unknown black male adult with shoulder length dreadlocks was shooting an unknown make or model firearm at the scene. Under Event #090823-3579 LVMPD Dispatch received information that the victims of the shooting from Crystal Palace were currently at 1300 Ralston Drive, Las Vegas, Nevada 89106. Violent Crimes Detectives Hall, P#6756 and I, Detective Bunting, P#6484, responded to the residence and came in contact with Quincey Williams and Damein Bland. Detective Hall conducted a taped statement with Damein Bland. Bland stated he drove to the Crystal Palace skating rink with his friend Quincey Williams. Upon their arrival they entered the business and while seated inside Floyd Mayweather, date of birth 02-24-77, I.D. #1363917, approached Williams and confronted him about a text message Williams had previously sent Mayweather approximately one month ago. The text message stated that he hoped that he lost his next fight. Mayweather threatened Williams stating he could have him trumped. Both Williams and Bland walked away from Mayweather. Bland stated that a black male adult who he knows as O.C. and Jackie Ray Jones were with Mayweather at the time. Bland observed Mayweather, O.C. and Jones leave

the business. Approximately ten minutes later Bland and Williams exited the business and observed O.C., Mayweather and Jones standing in the parking lot next to Mayweather's gray and blue Rolls Royce. He and Williams got into a 2006 BMW two door vehicle bearing Michigan plate 4JVV21 and began to exit the parking lot. Bland observed O.C. reaching into his groin area and shortly after heard gunshots. Bland looked and saw O.C. with a firearm in his hand and a flash coming from the firearm while he was standing next to Jones and Mayweather. Bland then fled area and went to Williams' residence. CSA S. Joseph, P#8178, responded and processed the vehicle and identified six apparent gunshot holes on the driver's side and rear portion of the vehicle. I, Detective Bunting, conducted a taped statement with Williams whose story was consistent with Bland's, however he was unable to identify who the shooter was. Both Bland and Williams confirmed that O.C. is a known associate of Mayweather's and known to carry firearms. They also describe him to have shoulder length dreadlocks, which was consistent with independent witnesses at the scene. Detective Hall and I along with patrol officers responded to Mayweather's residence at 2 Woodcreek Court, Las Vegas, Nevada 89141. Lieutenant D. Flynn, P#3028, made contact with Mayweather at his residence. Mayweather confirmed he was at Crystal Palace with Jones, but stated he didn't know an O.C. and was unaware of any shooting. Mayweather also stated he was

with Tommy and both Bland and Williams also mentioned Tommy in their statement, but said they didn't see him during the shooting. Mayweather also confirmed he drove his Rolls Royce bearing Nevada plate 463VKE, which was parked in his driveway at the time of our arrival. The Rolls Royce matched the description provided by both Bland and Williams and was two toned gray over blue. After speaking with Mayweather a premise freeze was placed on the residence pending a Search Warrant.

The affiant prays this Search Warrant authorize a night time search for the following reasons: LVMPD officers have a premise freeze on the residence and to prevent the loss of any evidence.

Judge Bixler, this ends the probable cause details, do you want me to read the duplicated Search Warrant?

JB. No, you don't need to read the duplicate.

CB. Judge Bixler, this ends the probable cause portion of the Search Warrant. Judge Bixler, do you find that probable cause exists for the issuance of the Search Warrant?

JB. Yes, I do.

CB. Okay, Judge Bixler, do you authorize a night time search clause?

JB. Yes.


