**CIRCUMSTANCES OF ARREST**

On June 19<sup>th</sup> 2010, the L.V.M.P.D. was called by the Luxor security regarding a person who had been punched in the chest and had been transported to the hospital after becoming unresponsive. The person, later identified as Damario Reynolds died after arriving at the hospital. Dr. Beccio, the attending physician at Desert Springs Hospital, pronounced the time of death as 0445 hours on June 19<sup>th</sup> 2010.

Detectives responded to the scene at the Luxor and to Desert Springs Hospital to look for evidence and interview witnesses. At the Hospital, detectives learned that a party was being held in suite 13335 of the Luxor Hotel and that the victim and the suspect, identified as Jason Sindelar, both attended. Detective Bunting spoke with Sindelar's girlfriend, Charmaine Kemp who was also at the party.

Kemp told detectives the following. While in a verbal confrontation with Jason Sindelar in the master bathroom of room 13335, Iman Aubrey requested they leave. A few minutes later Demario Reynolds, who is close friends with Sindelar, entered the bathroom and asked him to leave the hotel room because of the disturbance he was causing. Sindelar refused. Kemp observed Reynolds on top of Sindelar holding him in a bear hug on the bathroom floor. Reynolds told Sindelar that he didn't want to fight with him, that he loved him and he just needed to calm down. Kemp was unsure how they ended up on the ground.

Reynolds let go of Sindelar and went into the master bedroom. Sindelar spoke with Kemp in the bathroom for a moment then went into the master bedroom. Kemp heard what she described as punches being exchanged in the master bedroom. Kemp exited the bathroom and saw Reynolds on top of Sindelar bear hugging him once again making similar comments as he made in the bathroom. He also stated he was tired at which time Kemp held Sindelar down while Reynolds got up then laid down on the bed.

Both Kemp and Sindelar got up off the floor and began exiting the bedroom. Suddenly, Sindelar turned and began running toward Reynolds to fight with him again. Reynolds stood up to defend himself and they exchanged punches until they were split up by witnesses. Both Kemp and Sindelar then left the apartment.

Detective Wildemann spoke with Iman Aubry, Rochelle Galloway and Ebony Denis-Jordan, all of whom also attended the party. Aubry stated she and the victim are in a romantic relationship. That during the party, the suspect got into a domestic argument with his girlfriend, Charmaine Kemp. The argument became heated and the victim tried to intervene. Sindelar tried to grab Kemp by the throat and slapped her. Sindelar continued to be belligerent. Aubry saw Jason continuously hit Reynolds in the head and the chest. Aubry walked Reynolds out of the bedroom where the fight occurred and Reynolds sat on the couch. Reynolds was sweating and out

of breath. Sindelar had left the suite by that time but very soon after came back in the suite and began hitting Reynolds in the chest. Sindelar Pulled Reynolds on the floor and Reynolds took a defensive position while Sindelar continued to hit him. Members of the party were able to separate Reynolds and Sindelar and get Reynolds back on the couch. Reynolds then became unresponsive and security was called.

Miss Galloway stated she went to the party and Kemp and Sindelar were fighting and Reynolds tried to break the two up. Sindelar was extremely intoxicated and wouldn't listen and continued fighting. Reynolds tried to intervene again and Sindelar attacked Reynolds and began fighting him. The fight went from the bathroom to the hallway to the bedroom. Several punches were thrown before the two quit fighting. Sindelar left the suite and went into the hallway. After a few seconds out of the suite, Sindelar returned to the room and attacked Reynolds while Reynolds was on the couch and repeatedly punched him in the chest. The two were separated again and Sindelar once again left the suite. Reynolds became unresponsive. One of the other guests started C.P.R. and security was called.

Miss Denis-Jordan stated she was at the party and Sindelar and Kemp were fighting in the back bathroom and Reynolds intervened. Sindelar punched Reynolds in the chest and face and a fight broke out. Reynold was telling Sindelar to stop and to calm down but the fight continued. Sindelar bite Reynolds in the finger. Sindelar and Kemp left the suite and Reynolds went into the livingroom and laid on the couch. Denis-Jordan was sitting on the couch next to Reynolds. Denis-Jordan said she went to get Reynolds a drink of water and when she came back, Reynolds was unresponsive. Denis-Jordan stated she never saw Sindelar come back into the room but said he possibly did while she was getting water for Reynolds.

Sindelar was interviewed by Detectives at the L.V.M.P.D. office. Sindelar was read his rights per Miranda and stated he would speak with detectives. Sindelar stated he was at the party and was arguing with Kemp. He stated while he was arguing with Kemp. Reynolds grabbed him by the throat and pulled him out of the room. Reynolds took Sindelar to the ground and bear hugged him. Sindelar was able to escape but while doing so, might have bite Reynolds in the arm. Sindelar left the suite but returned a short time later and argued with Reynolds. He stated no further physical altercation occurred. Sindelar had several visible injuries on his person which Crime Scene Analysts photographed.

Due to the fact that the witness statement said Sindelar was the primary aggressor and the fact that Reynolds was not fighting back and that Sindelar came back to the suite and further attacked Reynolds, striking Reynolds repeatedly in the chest, and that Reynolds became unresponsive after the second attack and dies a short time later, detectives placed Sindelar under arrest for murder and transported him to CCDC where he was booked.
